## Standing Councils, Commissions, and Committees 2021-22

Revised 5/5/22

## Preamble

Education requires the oversight and management of a multitude of tasks and assignments. Shared governance at an educational institution offers the opportunity for faculty and staff to assist administrators with those tasks by providing input, recommending outcomes, and participating in operational decisions. In addition to committees appointed directly by the Faculty Senate and ad hoc committees created for special purposes, the Oregon Institute of Technology recognizes a number of standing committees, commissions, and councils that provide continuous support for institutional or academic leadership. Each assembly reports to one of the University's Vice Presidents or to the President. These administrators recommend membership and service on the committees reporting to them to the President for approval. Recommendations for membership and service on the committees reporting to Faculty Senate are made to the President of the Faculty Senate for approval. Oregon Tech is committed to diversity, equity, and inclusion in committee representation.

Two types of committee appointments are recognized:

- Appointment to a committee because of job title or position (e.g., Vice Provost on President's Council).
- Appointment for a rotating term.

The term of service varies according to appointment type:

- Committee members appointed because of job title or position typically serve while holding the position, dependent on the purpose for the position to serve on the committee.
- Student appointments serve for one-year renewable terms.
- Committee members appointed for rotating terms typically serve three years, unless otherwise specified within the committee description.
- Committee members appointed for rotating terms in elected positions (e.g., Faculty Senate) serve according to their elected term within the assembly.
- Members may be reappointed for an additional three-year term (six years total), but it is the intention of this process to encourage broad participation and to allow faculty and staff to bring fresh perspectives and skills to their committee assignments. This is deemed especially critical for high profile assignments that impact promotion and tenure decisions. Members can be reappointed after a term off the committee.
- Appointed members have staggered terms so that some membership continuity is present.

Individuals can request consideration for membership on a particular committee at any time by petitioning the Provost or President of the Faculty Senate, for the committees reporting to administrators and Faculty Senate, respectively. The Office of the Provost will affirm membership and notify appointees for the succeeding academic year before the start of the fall term.

The academic community recognizes the importance of committee assignments and the role it plays in shared governance. However, committees that are unwieldy in size often have difficulty in meeting
or reaching a quorum. Members who are regularly absent can be removed from a committee, at the request of the committee Chair, to the appropriate reporting Vice President. Likewise, a Chair who is deemed inefficient and unable to organize committee business can be removed at the request of committee members, to the appropriate reporting Vice President. Assignment to a committee should be regarded as a privilege and responsibility.

Council, commission, and committee chairs/co-chairs are required to submit a brief summary report at the end of spring term to provostoffice@oit.edu. The Provost's Office will collect and distribute the reports to the appropriate division leaders.

## PRESIDENT'S DIVISION

## Oregon Tech President's Council

To assist in the formulation, drafting, revision, recommendation, and maintenance of the Board's and University's policies, the Board directs the President to establish and maintain a policy council. The Oregon Tech President's Council (Council) will be convened by the President or President's designee on at least an annual basis.

The Council is a consultative, multi-functional group designed to provide valuable input and advice to the President on the categories of authority described in Board Policy. The Council has the following supplementary responsibilities:

- Identify and seek solutions to problems crossing college jurisdictions.
- Maximize the planning efforts of the institution.
- Enhance the communication processes within the institution.

With the approval of the President, potential members of the Council may consist of, but are not limited to, the Provost; Vice Provost; Vice Presidents; Associate Vice Presidents; College Deans; University General Counsel; Presidents of Faculty Senate and Associated Students of Oregon Institute of Technology; and the Chair of the Administrative Council. The Academic Affairs division will serve as Secretary and provide administrative support.

## DICE Steering Committee

Each public institution of higher education shall establish a process for recommending and providing oversight for the implementation of cultural competency standards for the public institution of higher education and the institution's employees. The process established under this subsection must:

- Include a broad range of institutional perspectives.
- Give equal weight to the perspectives of administrators, faculty members, staff, and students.
- Require that the institution provide continuing training and development opportunities that foster the ability of the institution's faculty, staff, and administration to meet cultural competency standards.
- Propose institution-wide goals that seek to improve the cultural inclusion climate for students, faculty, staff, and administration from diverse backgrounds.
- Require preparation of a biennial report that is presented to the appropriate board regarding the institution's progress toward achieving the goals set forth in this subsection.
- Recommend mechanisms for assessing how well the institution meets cultural competency standards.
- Ensure that the institution clearly communicates to new faculty, staff, and administrators the institution's commitment to including meeting cultural competency standards in professional development.

The Vice President for Finance and Administration serves as the chair.

## Fiscal Operations Advisory Council

The Fiscal Operations Advisory Council (FOAC) is a joint council of faculty, administrative staff, and students for the purpose of advising the President on budget and financial matters. FOAC will participate in the general operating fund budget planning process; review the call for budget development from the President; and recommend fiscal management priorities to align with the strategic goals of Oregon Tech considering both the long-range fiscal priorities and budget planning as well as immediate fiscal and budgetary issues. FOAC will review the institution's annual budget and advise the President on the development of new budget initiatives. As needed, FOAC will review and advise on the format for reporting the annual budget to the campus community. The Council will function as an integral group in strategic planning activities, with a university-wide perspective.

Members of FOAC include the Provost; the Vice Presidents for Finance and Administration, and Student Affairs; the Vice Provost for Research and Academic Affairs; three committee members selected from the University staff and administration appointed by the President; a member of the Faculty Senate Executive Committee appointed by the Faculty Senate President; a representative of Administrative Council appointed by the president of Administrative Council; a representative of the Budget and Resource Planning office appointed by the Vice President for Finance and Administration; the ASOIT President(s) (or designees); and four senior faculty members appointed jointly by the President and the Faculty Senate President. The Faculty Senate President will advance at least six names annually to the President for consideration. The chair is appointed by the President.

## Health and Wellness Committee

The Blue Zones Project was a community-wide well-being improvement initiative to help make healthy choices easier for Oregonians. In Spring 2017, Oregon Tech’s Klamath Falls Campus was approved as the 14th Blue Zones Worksite in the Klamath Basin and the 1st university with the distinction on the West Coast. In Fall 2021, as planned, the "Blue Zones Project" left the Klamath Basin and spearheaded by Sky Lakes Medical Center will continue the project work under the new branding of Healthy Klamath. In Winter 2021, the Wellness committee strategically identified new goals and priorities to become a broader, campus-wide, university-wide effort.

The Wellness Committee is tasked with:

- Identifying strategies that will improve the well-being and total comprehensive fitness (physical, mental, social, and spiritual) of Oregon Tech employees.
- Establishing, monitoring, and reporting wellness outcomes.
- Improving awareness of available wellness resources.
- Removing barriers to wellness in the workplace while creating an atmosphere that is supportive of employee health and wellness.

The committee is comprised of a minimum of five staff members, including representatives from Athletics; Dining Services; Student Affairs; Human Resources; a minimum of four faculty with representation from both colleges; and student representatives.

## Student Awards Commission

## Title IX Steering Committee

The Title IX Steering Committee (Committee) is a collaborative and multi-disciplinary team charged with advancing a culture of respect, responsibility, and safety at Oregon Tech. The Committee provides the Title IX Coordinator with recommendations on promoting a positive campus culture and in identifying and deploying effective measures to prevent and address sexual misconduct, including sexual assault, sexual harassment, domestic violence, intimate partner violence, dating violence, and stalking. The Committee offers recommendations and guidance to the Title IX Coordinator to inform policy and procedures, identify services, and ensure positive compliance with Title IX and other laws, regulations, and policies related to sexual and gender-based issues. The full Committee meets at least quarterly and when needed. The subcommittees meet monthly, except on months when the full Committee meets.

## Core Committee Responsibilities

The Committee will:

- Discuss ways to advance systemic change and overall improvements to the campus climate relating to Title IX protections, rights, and responsibilities.
- Assist in the development and implementation of an overarching compliance plan consistent with both the legal obligations of Title IX and Oregon Tech's strategic plan and initiatives.
- Assist the Title IX Coordinator and Deputy Coordinators in monitoring changes in Title IX laws and regulations and benchmarking with other institutions on the most effective and efficient ways to assure Oregon Tech implements sound Title IX practices, provides effective education and training, and adopts effective outreach and prevention efforts.
- Collaborate with other committees and institutional partners in coordinating Title IX efforts and related efforts (e.g., Clery Act, the Campus SaVE Act, and Oregon House Bill 3415 compliance).
- Create subcommittees focusing on the following core components of Oregon Tech's overall Title IX Compliance Program: (a) compliance plan; (b) related policies and procedures; (c) effective education and training; and (d) proactive outreach and prevention efforts and initiatives.
- Develop a consistent and effective reporting system to the Title IX Coordinator, the President, other members of Oregon Tech's senior leadership, and, when requested or appropriate, the Board.


## Committee Members

## Standing Subcommittees

The following are the standing subcommittees of the Committee. Additional ad hoc and working committees may be needed from time to time and will consist of volunteers from the Committee and external stakeholders, when appropriate or necessary.

Compliance Plan: Charged with assisting the Title IX Coordinator in the drafting and adoption of a written annual or multi-year compliance plan detailing goals and objectives, self-auditing, benchmarking, etc.

Policies and Procedures: Charged with reviewing or updating written policies and procedures, as needed. For procedures that end up embedded in collective bargaining agreements, the chair would serve as a resource for the union negotiating team, when negotiations are active.

Education and Training: Charged with developing, updating, and assisting in the scheduling and delivering of training and education, including online resources, live, and, as applicable, online training, for faculty, staff, and students.

Outreach and Prevention: Charged with developing, updating, and assisting in the delivery of outreach and prevention efforts for faculty, staff, and students.

## Tuition Recommendation Committee

The Tuition Recommendation Committee (TRC) is responsible for recommending the tuition and mandatory fee rates to the President, who must in turn report and recommend mandatory tuition and fee rates to the Board of Trustees in accordance with ORS 352.102. The Board of Trustees shall request that the President transmit to the Board the joint tuition recommendation of the President and the recognized student government.

The TRC is comprised of six students representing both campuses and appointed by the ASOIT president(s), two of which represent ASOIT and two of which represent historically underserved students of the University, as defined by the University; the Fiscal Operations Advisory Council (FOAC) chair; and at least two administrators. Any changes to the TRC structure required by ORS 352.102, subsequent controlling statutes or Board Policy may be made without notification. The President shall designate one member to chair the TRC.

Before making any recommendation to increase tuition and mandatory fees, but especially when the proposed increase is more than five percent annually, the TRC must document its consideration of the impact on students and the necessity of the increase in achieving the mission of the University. The TRC shall provide meaningful opportunities for members of the student government and students at large to participate in the process and deliberations.

The TRC will meet at least twice during January - February. Its meetings shall be open to the public and broad notification of the meetings shall be made to the University community. The TRC will consider the guidelines provided by the Board, information provided by the Administration, and such other matters as deemed appropriate.

## Accreditation Committee

The Accreditation Committee is an advisory body to the Provost. The committee reports to the Provost. The Accreditation Liaison Officer (ALO), selected by the President, serves as its Chair. The primary roles of the committee include providing guidance on university accreditation issues and assisting as needed with programmatic accreditation. The committees represents faculty and the administration in accreditation activities and guiding the development and implementation of the University's institutional effectiveness planning as required by the Northwest Commission on Colleges and Universities' (NWCCU) Accreditation Standards.

The committee will achieve its objectives through working with campus stakeholders to identify and use ongoing measures of institutional effectiveness and student achievement, the development and implementation of improvement plans, and the documentation of these processes as required for NWCCU accreditation.

Members are selected from faculty and staff for their experience and ability to influence and provide input into creating processes and procedures by which these measures and their outcomes can contribute to institutional decision-making. As such, the committee includes executive-level staff (or their designees) in areas that impact student achievement, as well as representation of perspectives from both academic leadership and faculty. Per se, membership is selected with a strong preference for experience in leadership, assessment, or accreditation. If the ALO is "double-listed" in the committee membership below, the Provost may appoint a designee in their stead. College faculty are selected by the College Deans; at-large faculty are jointly appointed by the Provost and ALO.

## General Education Advisory Council

The provost shall appoint one faculty member to serve as chair for a two-year term (may be reappointed). A vice chair may be appointed from the membership of GEAC to support continuity of leadership, particularly during the last year of a chair's term.

## Promotion Advisory Committee

The intention of appointment to PAC is for faculty members to represent the entire institution, not to represent their respective departments, disciplines, or colleges.

## Safety Commission

The purpose of the Safety Commission is to bring members of the campus community together in a cooperative effort to promote safety and health in the workplace. An effective safety commission assists the employer and helps identify recommendations for change. The goal is to reduce or eliminate on-the-job accidents by use of every reasonable precaution.

The Commission is mandated under OSHA rules to meet on a monthly basis. The Commission exists to receive and manage university-wide safety suggestions, reports of safety hazards, and workplace safety concerns. The Commission recommends safety policy and safety procedural improvements to the President through the Vice President for Student Affairs. The Vice President for Student Affairs is an ex officio, non-voting member of the Commission, who may attend meetings to facilitate receipt of safety recommendations. The Commission will conduct quarterly inspections of Klamath Falls, Portland-Metro, and extension campuses to review and document safety progress campus-wide.

The Commission is comprised of the Vice President for Student Affairs (or designee); Vice President of Finance and Administration; the Directors of Facilities Management Services, Campus Security, and the Integrated Student Health Center (or designees); the College Union manager (or designee); one faculty member from each college; and an ASOIT student representative from each campus. Other members include one or more representatives from each of the following areas: trades, food services, custodial, support services staff, health services, environmental health and safety, security, Klamath Falls and Portland-Metro instrument technicians, and computing services. The Portland-Metro members of this commission will serve as a site-specific subcommittee to the University Commission. This Commission reports directly to the Vice President for Student Affairs. The chair is elected by the Commission members.

## Student Hearing Commission

The President designates one of the faculty members to be the chair. A quorum (a majority of members, one of whom is a student) is needed to make recommendations.

## Traffic Commission

The responsibilities of the Traffic Commission include the following:

- Establish equitable rules and regulations relative to traffic control on campus.
- Distribute regulations governing traffic control on campus.
- Establish means for enforcement and hear appeals of violations of traffic regulations.
- Recommend means of improving traffic control and safe driving on campus.
- Recommend maintenance and construction projects related to parking.
- Recommend to the Vice President for Finance and Administration parking fees and fines sufficient to support parking operations.

The Traffic Commission will designate members of its standing commission to act as Traffic Appeals Board members. Members are required to participate at least once on the Appeals Board during their Traffic Commission tenure. The Board renders decisions on the appealed citations based on State of Oregon statutes and the Oregon Tech vehicle regulations. The Board consists of one faculty member, one staff member, and one ASOIT officer.

The Vehicle Accident Review Committee is a subcommittee of the Traffic Commission. It is charged with reviewing all accidents involving state vehicles owned by Oregon Tech or driven by its employees. A determination is made as to the cause of each accident, whether it could have been avoided, and whether any further action should be taken. The Vehicle Accident Review Committee, when convened by the Director of Campus Security, will be composed of selected members of the Traffic Commission and anyone else necessary to complete the investigation.

The Commission is comprised of three faculty; three administrative/classified staff; four students; representatives from the Budget and Planning Office; and Facilities Management Services. The Director of Campus Security will serve as the chair. This Commission reports directly to the Vice President for Student Affairs.
