This letter serves as formal notification and official record of action taken by the Northwest Commission on Colleges and Universities (NWCCU) at its meeting on June 21-23, 2023, concerning the Spring 2023 Evaluation of Institutional Effectiveness of Oregon Institute of Technology. This action was taken after consideration of evidence, including the institution's Self-Evaluation Report, the Peer-Evaluation Report, the optional Institutional Response to the Peer-Evaluation Report, and information received as part of the institutional representative meeting with Commissioners.

Commendations

The Commission commends Oregon Institute of Technology for:

- 1. Their passionate commitment to students, including their learning, belonging, and future success.
- 2. Its commitment to its institutional mission as a polytechnic university as demonstrated through learning outcomes aligned with industry standards, industry partnerships that facilitate meaningful externships, high job placement rates, and industry-imbedded research opportunities.
- 3. On the design of its student success data dashboard, which makes it particularly easy and intuitive for faculty and administration to find the information needed to make data-driven decisions.
- 4. The library for cross-departmental collaboration in support of student success, including the use of the library space for student events and for supporting diversity, equity and inclusion on campus through the purchase of needed materials.

- objectives, establish and oversee academic policies, and ensure the integrity and continuity of its academic programs. (2020 Standard(s) 2.F.3)
- Recommendation 3: Spring 2023 Evaluation of Institutional Effectiveness Use an ongoing and systematic evaluation process to inform and refine its institutional effectiveness and assign resources. (2020 Standard(s) 1.B.1)
- Recommendation 4: Spring 2023 Evaluation of Institutional Effectiveness Provide evidence that its
 planning process is inclusive and offers opportunities for comment by appropriate constituencies,
 allocates necessary resources, and leads to improvement of institutional effectiveness. (2020
 Standard(s) 1.B.3)
